

# **BHS PROJECT GRADUATION 2024**

Please read the information about Project Graduation below. The attached page is where you will indicate if you **WILL** or **WILL NOT** attend. We are asking all seniors, attending or not, to turn in the 2nd page by May 14, 2024 to Mrs. Denton in the AP office (upstairs D building).

## **What is Project Graduation and who is permitted to attend?**

Project Graduation is a drug, alcohol, and smoke free graduation party sponsored by the Burnet Project Graduation Committee. It provides a safe place for our graduates to celebrate with their classmates. Project Graduation is a privilege for the students who are graduating from Burnet and Quest High School and is provided at no cost to the graduates.

## **When and where is it?**

Project Graduation will be held on Graduation Night Friday, May 24, 2024 from 11:00 p.m.- 6:00 a.m. at Putters and Gutters in Marble Falls, Texas.

## **How do the students get there?**

Bus transportation will be provided from the gym parking lot of Burnet High School. Graduates should arrive at the school no later than 10:30 p.m. Under **NO CIRCUMSTANCE** will a graduate be permitted to drive themselves to the site. Graduates will return to the high school at approximately 6:30 a.m. \*Graduates **WILL NOT** be allowed to leave the facility for any reason! Graduates must wear school appropriate clothing.

## **What if someone has been drinking and attempts to board a bus?**

Anyone who has been drinking or is under the influence of drugs will not be permitted to participate in the activities. The graduate will be detained in a separate area until their parents and the police are notified. The parents will be required to escort them home.

## **What kind of activities are planned?**

There will be a variety of activities for the graduates to participate in. There will be music and games throughout the evening. To name a few; there will be bowling, putt-putt, karaoke and a hypnotist/magician who will be entertaining throughout the evening. Food and beverage will be provided, as well as an early morning breakfast.

**PLEASE NOTE: NO CUPS, WATER BOTTLES OR OUTSIDE FOOD WILL BE PERMITTED.**

**What should the graduate bring?**

Dress comfortably and bring socks if you wish to bowl. If you bring a bag, the bag must not exceed the size of a backpack. Clear bags are preferred.

The Code of Student Conduct as outlined in the BHS Student Handbook applies during this event.

Any bags will be subject to inspection by the chaperones prior to boarding a bus for intoxicants and/or drugs. Please note that if alcohol, drugs or drug paraphernalia of any kind is found during the search, parents and the police will be notified. All unlawful acts must be referred to the proper legal authorities.

Prescription drugs must be checked in with the medical chaperone in attendance. All prescription drugs must be accompanied by a note of explanation on the permission slip.
